ELECTIONS 2017

Sub- county and zonal elections begin tomorrow 28th January 2017 and I am glad many sub-counties are already set for the same. However, I wish to highlight one matter that is in the POR but was not conclusively explained in the election guidelines shared before. I make reference to rules 72, 73, 74 and 75 of the POR on Teams of the Association. The Teams: Training, Youth Programme, Administration and Youth Leader will perform the following tasks during the AGM:

a) Training Team

- i. Elect 10 members to form National Training Sub Committee
- ii. Nominate from the 10 a Chairperson and a Vice Chairperson. The Chairman shall be appointed as Assistant Chief Commissioner - Training.
- iii. Nominate one Leader Trainer for appointment as a member of the National Scout Board.

b) Youth Programme Team

- i. Elect 10 members to form National Youth Programme Sub-committee.
- ii. Nominate from the 10 a Chairperson and a Vice Chairperson. The Chairperson shall be appointed as Assistant chief commissioner - Youth Programme.
- iii. Nominate one member for appointment as a member of the National Scout Board.

c) Administration Team

- i. Elect 10 members to form Administration Team Sub-committee
- ii. Nominate two members as Chairperson and Vice Chairperson of the sub-committee respectively. The Chairperson shall be appointed as Assistant Chief Commissioner - Administration.

- iii. Nominate one member for appointment as a member of the National Scout Board.
- d) Youth Leaders Team
 - i. Elect 10 members to be members of the National Youth Leaders Subcommittee
 - ii. Nominate two members (male & female) to serve as Chairperson and Vice Chairperson of the National Youth Leaders Sub – committee.
 - iii. Nominate one member for appointment as a member of the National Scout Board.
