RE: NOTICE OF THE ELECTION OF THE CHIEF COMMISSIONER, KENYA SCOUTS ASSOCIATION

Established by an Act of Parliament Cap 219 of the Laws of Kenya, the Kenya Scouts Association is an educational Movement for young people, which provides non-formal education that complements the corecurriculum offered in our education institutions.

Pursuant to Chapter 8, Article XXVIII, 2 on 'Assumption of Office' the National Scout Council will be putting for election the position of the Chief Commissioner of the Kenya Scouts Association after a cycle of five years on 26th November 2022 during the Council Annual General Meeting. The person elected then shall serve as Chief Commissioner for the subsequent five years.

Suitably qualified candidates are thus invited to put in their applications for the position. Below are the details that should aid your application:

KEY RESPONSIBILITIES

- Responsible for overall Leadership and Management of the Association
- Chair meetings of the National Scout Board
- Chair the National Council meeting in the absence of the Chief Scout
- Appoint National Commissioners in consultation with the Chief Scout and the elected members of National Scout Board
- Ensure proper delivery and implementation of the Scout Program
- Resource mobilization for the Association 6.
- Co-ordinate the work of all Commissioners
- Sign warrants for Commissioners and other Scouters.
- Registration of County Scout Councils
- 10. Withdraw, suspend or cause to be withdrawn the warrants or temporary permits of any Scouter upon recommendation from the relevant committees.

- 16. Present a progress report for the preceding year to the AGM of the National Scout Council
- 17. Any other duties as may be assigned by the Patron or the National Scout Council
